Summary Minutes from Thursday, February 20, 2003

1. Summary Minutes

a. Review and Confirmation of Working Committee Guidelines

The Committee members discussed their desire to approach the discussions with open minds and no pre-set agendas. Each member has interests, insights, and information to share. This is different, however, from advocating a pre-set position or solution. The Committee members unanimously affirmed the following policy guideline:

"While acknowledging that some members may have previously taken positions about marine resource protection issues, Working Committee members agree to openly consider the facts and options that may arise and to suspend further public advocacy of such positions until the Committee concludes its recommendations." In the unlikely event that elected officials serving on the Committee are called upon to vote on marine resource protection issues prior to the conclusion of the Committee's recommendations, everyone understands that this guideline does not preclude them from exercising their responsibilities.

b. Additions to the Working Committee

At its previous meeting, the Working Committee indicated an interest in additions in several areas, including marine-dependent businesses, at-large members, and sport fishing. It reviewed the submissions from nominees in these categories. The Committee decided to add one representative of marine-dependent business interests, two at-large members, and one sport fishing. The persons receiving the most votes in these categories and, thus, becoming new members of the Working Committee are: Steve Moore, Leslie Krinsk, Dave Sears, and Dave Rymal.
